

## List of Acceptable Alternative Standards to ISO 9001:2008

IRCA has determined that, for the purposes of conformance with the IRCA/602 QMS 2008 auditor certification criteria, the submitted standards detailed in this document are considered acceptable alternatives to the ISO 9001:2008 Standard.

IRCA's evaluation of these standards includes a technical review for the purposes of validation of acceptability of an applicant's claim of experience "equivalent" to auditing Quality Management Systems to ISO 9001:2008. This evaluation is used only to determine whether audit experience using these standards meets the audit experience requirements stipulated in the IRCA auditor certification criteria. It is not intended as a technical review of the equivalence of a standard to ISO 9001:2008.

IRCA will review submitted standards, update and reissue this list periodically.
